

Essential Instructions for Electrochemistry Trivia 2019

- Please visit the Event Link <<https://events.vtools.ieee.org/m/212221>> for the syllabus, quiz pattern, and future updates of the quiz.
- **Submission ID field:** It is the respondents' unique ID or entry token; any change in this will make you disqualified for the quiz. This field is required to allow us to fetch your submission data. You don't need to fill it in, and this field will be pre-populated automatically for you by using the entry link sent to the respondent.
- **Unfocused:** It will tell us how focused the respondent was while filling out the form. "Unfocused" shows the number of times the respondent left the Quiz Page, for example, opened another tab, application, minimize quiz or window.
- Permitted Time is 60 minutes, which will start automatically when the respondent opens the form.
- The Link which is provided to the respondent is a one-time link, hence, do not use it otherwise intended to give the quiz. No second link will be provided to the respondent in any case.
- After the reception of the Quiz Link, the respondent can take the test anytime during the quiz period from 8th December 2019 to 9th December 2019 midnight. Although, the respondent has to give the entire quiz in one go without any refresh or loss of connectivity.
- The respondent needs to sign in only with one Email ID at the time quiz provided during registration on which the link is received.
- Respondents are responsible for arranging computers/laptops with active high-speed internet connection for the entire duration of the quiz. IEEE AcSIR CSIO or its affiliates are not responsible for any technical problem during the quiz duration. Non Submission leads to disqualification.
- Quiz Platform is not tested on smartphones. Any errors or issues due to this are not accountable by IEEE AcSIR CSIO or its affiliates.
- The answers cannot be submitted automatically; they can only be submitted when the respondent clicks the "Submit" button in the form. Although time duration is being recorded until the respondent submit the Quiz.

Marking Scheme for Electrochemistry Trivia 2019

Marks Deductions:

- **Wrong Answers:** 25% of Marks of each incorrect question will be deducted
- **Unfocused:** 1 Mark will be deducted for each time you leave the Quiz Page
- **Overtime:** 1.2 Marks will be deducted for every 1 minute (0.02 Mark per second)
- No deductions for Permitted time, which is 60 minutes from the time of opening the Quiz. Although in the event of a tie, it may be considered depends upon the decision of the IEEE AcSIR CSIO, Chandigarh Executive Committee.

For Example:

The respondent attempted 22 questions (09 one marker, 09 two marker, and 04 four marker questions) in 61 mins. Of them, one question wrong in each category and also changes the screen two times. The calculations of Marks are below:

- **Marks Scored from correct answers:**

$$8 \times 1 + 8 \times 2 + 3 \times 4 = 36$$

- **Marks to be deducted from wrong answers:**

$$1 \times 0.25 \times 1 + 1 \times 0.25 \times 2 + 1 \times 0.25 \times 4 = 1.75$$

- **Unfocused Marks Deduction:**

$$2 \times 1 = 2$$

- **Marks to be deducted for Overtime:**

$$1.2 \times 1 = 1.2$$

- **Final Marks:**

$$36 - (1.75 + 2 + 1.2) = 31.05$$
